# <u>Introductions</u>, <u>Background</u>, and <u>Project Updates</u>

• There have been no changes to the list of Consulting Parties and no changes to the project design since our last meeting.

### Status and Schedule Review

- The Draft Programmatic Agreement (PA) comment period closed on Monday, September 21. OEA is now making revisions to the PA and may reach out to individual commenters as necessary. The revised PA will be included in the Draft EIS which will be issued at the end of October.
  - Jeff Rust asked whether the land management agencies can review the revised PA before it is published in the Draft EIS. Alan agreed to share the revised document with land management agencies once it is ready.

• OEA has been preparing the Technical Memo over the last few months and it will be distributed for Consulting Party review in October.

## Technical Memo Review

- Colleen reviewed the overall structure of OEA's Technical Memo. In general, there are two categories of analysis for eligible properties. The first are a group of properties that OEA is making an eligibility determination for and that will be submitted to SHPO for concurrence. The second is a group of properties that OEA will treat as eligible but will not be submitted to SHPO for concurrence. These properties are all potential historic district contributors.
  - OEA has identified a potential Uinta Basin rural historic district, a potential Indian Canyon Road linear historic district, and a potential Emma Park Road linear historic district.
  - o Jeff Rust agrees with OEA's decision to treat the potential historic district contributors as eligible at the stage.
- Dennis Willis asked whether the Technical Memo will include information as to which alternatives each resource i is associated with. Alan reviewed a sample resource summary from the Technical Memo. It includes information on the relevant alternatives as well as information about regarding the resource's location in relation to the project footprint and potential effects.
- OEA is also making determinations for resources that are not eligible, and those will be submitted to SHPO for concurrence.
- OEA's Technical Memo will include a number of attachments covering topics such as consultation, a mapbook of the APE, an ethnographic overview, and detailed mapbooks for each potential historic district.
- Jeff Rust asked whether the Technical Memo will be going out with the Draft EIS. Alan clarified that it will be distributed to Consulting Parties prior to the Draft EIS being issued, but it will also be attached as an appendix to the Draft EIS.

# **Other Topics**

• The Nine Mile Canyon Coalition is concerned about indirect impacts to cultural resources in Nine Mile Canyon from downstream impacts from changing drainage patterns. They suggested OEA include this in the PA. OEA will review the PA as they are making revisions and ensure this issue is adequately covered.

### Next Steps

- OEA Actions
  - o Alan Tabachnick will review PA comments with land management agencies to ensure their comments have been addressed.
  - OEA will distribute the Technical Memo to Consulting Parties in October.
  - OEA will review the PA as they are making revisions and ensure that downstream impacts from changing drainage patterns are adequately covered.
