## 1: CONTEXT AND OVERVIEW

### 1.1: Purpose of the Technical Memorandum


This technical memorandum is intended to serve as a synthesis of regulations and policies relevant to VTrans, Virginia’s Transportation Plan. It is not intended to be an official record of regulations or policies, and to that end, it does not provide the entire text, nor does it provide detailed interpretation or discuss the nuance of these policy items. Rather, it provides a compilation with links so that users may gather more detailed information.

These items were deemed to be relevant to VTrans through ongoing staff reviews at the Virginia Office of Intermodal Planning and Investment (OIPI). OIPI will continue to monitor policies and regulations to ensure VTrans continues to meet applicable federal and state requirements, and is in compliance with relevant policies.

### 1.2: About VTrans

VTrans is Virginia’s multimodal transportation plan. It is developed to establish and advance the Commonwealth Transportation Board’s (CTB) vision for transportation. VTrans is developed by the CTB with assistance from OIPI. As part of the VTrans planning process, CTB conducts a comprehensive assessment of transportation needs and long-term risks and opportunities to guide Virginia’s transportation future. VTrans has the following four major components, symbolized by four pillars in Figure 1.

## 2: FEDERAL REQUIREMENTS

It is a federal requirement for each US state to develop a statewide multimodal long-range transportation plan. The original impetus for this requirement was the development of the continuing, comprehensive, and coordinated ("3C") planning process between regions and states in the 1960's. Statewide plan requirements were updated over the years with each major federal transportation funding act. The current requirements were mostly solidified in 1991 with ISTEA, with additional requirements for performance-based planning added with MAP-21 in 2012. The requirements will continue to evolve.

The major sources of federal regulations are the Code of Laws of the United States of America (also known as the US Code) and the Code of Federal Regulations (CFR). The US Code is issued by the House of Representatives and is the official compilation and codification of the general and permanent federal statutes of the United States. The Code of Federal Regulations (CFR) is issued through the Federal Register. It lists the rules and regulations issued by the departments and agencies of the federal government (for example, USDOT, FHWA, FTA), not the lawmakers. The CFR often contains more detailed guidance provided by the agencies, but it does not contradict the US Code.

The main ruling describing statewide transportation plan requirements is Title 23 - Highways, Chapter 135 - Statewide and nonmetropolitan transportation planning of the US Code. The main CFR rules and regulations relevant to the statewide transportation plan are found in Title 49, Transportation.

Relevant US Code and CFR references are below. In addition to federal regulations, the Commonwealth of Virginia also has its own requirements for the Statewide Plan that go beyond the federal requirements. Those are shown below in a separate section of this document.
